This declaration is the Type III Environmental Product Declaration (EPD) based on EN 15804 + A2 and verified according to ISO 14025 by an external auditor. It contains the information on the impacts of the declared construction materials on the environment and their aspects verified by the independent body according to ISO 14025. #### **MANUFACTURER**

Kronospan is a producer of wood-based materials and products for the furniture industry made of certified, post-consumer and recycled wood. The company's offer includes a range of products that are widely used in construction, furniture and interior design.

It carries out production as part of sustainable development, using innovative technologies. In Poland, Kronospan has branches in Szczecinek, Mielec, Strzelce Opolskie, Pustków, Poznań, Rudawa, Szczecin and Rytel. It employs about 3,000 people, and indirectly creates jobs for about 18,000 people.

Kronoplan Kronoart's exterior-grade compact laminate products are manufactured in Pustków. In 1996, Kronospan started its operations there. The factory was established on the basis of one of the then existing departments of the local company - the laminate production department. In 1996-2006, the company underwent a series of complex technological changes related to the production of laminates. As a result of these changes, a new production plant was established, which uses the latest technological, technical and product solutions in the production of decorative laminates, countertops, compact boards or facade panels.

#### PRODUCTS DESCRIPTION AND APPLICATION

EDF Kronoplan Kronoart boards are designed for outdoor use in moderate and heavy conditions, exposed to direct sunlight, impact, thermal shock, weather and corrosion. Aesthetics aside, the technical purpose of ventilated facades is to protect the structure from weather and environmental conditions while providing effective thermal insulation.

EDF Kronoplan Kronoart is a solution for architectural facade claddings. Laminated under high pressure and at high temperature. EDF Kronoplan Kronoart is option for suspended ventilated facades, facings, sunshields, external partitions, fences and railings.

EDF Kronoplan Kronoart has closed surface properties, topped by a layer of varnish. This structure translates into high resistance to staining, impact damage and the effects of adverse environmental conditions. They provide fire retardancy in line with EN 13501 (up to the class B-s1,d0) DIN 4102 (up to the class B1) and NRO.

They are available in 75 décors in BS and WO textures.




Figure 2. Construction of EDF Kronoplan Kronoart

#### LIFE CYCLE ASSESSMENT (LCA) – general rules applied

#### **Declared Unit**

The declaration refers to declared unit (DU) – 1 m³ of exterior-grade compact laminates (EDF) Kronoplan Kronoart

#### **Allocation**

The allocation rules used for this EPD are based on general ITB-PCR A. EDF Kronoplan Kronoart production is a line process in one factory located in Pustków (Poland). Allocation is done on product mass basis.

All impacts from raw materials extraction and processing are allocated in A1 module of EPD. Above 99.5% of impacts from line production were inventoried and allocated to the production of EDF Kronoplan Kronoart. Municipal waste and waste water of whole factory were allocated to module A3. Energy supply was inventoried for whole production process. Emissions in Kronospan HPL Sp. z o. o. are calculated (energy combustion factors based) and were allocated to module A3. Packaging materials were not taken into consideration.

#### **System limits**

The life cycle analysis (LCA) of the declared products covers product stage – modules A1-A3, end of life – modules C1-C4 and benefits and loads beyond the system boundary – module D (cradle-to-gate with options) in accordance with EN 15804 + A2 and ITB PCR A. The details of systems limits are provided in product technical report. All materials and energy consumption inventoried in factory were included in calculation. Office impacts were also taken into consideration. In the assessment, all significant parameters from gathered production data are considered, i.e. all material used per formulation, utilised thermal energy, internal fuel and electric power consumption, direct production waste, and all available emission measurements. It can be assumed that the total sum of omitted processes does not exceed 5% of all impact categories. In accordance with EN 15804 + A2, machines and facilities (capital goods) required for the production as well as transportation of employees were not included in LCA.

#### Modules A1 and A2: Raw materials supply and transport

Raw materials such as phenol, melamine, formalin, methanol, varnish, kraft and decor paper come from external suppliers. Data on transport of the different products to the manufacturing plants is collected and modelled for factory by assessor. Means of transport include small trucks (< 10 t), big truck (>16 t) and container ship (for part of the structural foil delivery) are applied.

#### Module A3: Production




Fig. 3. A scheme of EDF Kronoplan Kronoart production by Kronospan HPL Sp. z o. o. (Poland)

Fig. 3 shows the manufacturing process during the production of the EDF Kronoplan Kronoart. The laminate manufacturing is basically a process including impregnation of kraft and decor paper, assembling, pressing, trimming, sanding and varnishing. Then the EDF Kronoplan Kronoart product is packaged and then stored prior to the shipment of the final product. The facility is PN-EN ISO 9001 certified.

#### Modules C1-C4 and D: End-of-life (EoL)

In the adapted scenario, deconstruction of the EDF Kronoplan Kronoart is performed with the use of electrical tools (module C1). The resulting waste is transported to a waste processing plant which is 50 km away, on 16-32 t lorry EURO 5 (module C2). It is assumed that at the EoL cycle 50% of the EDF Kronoplan Kronoart are recovered in municipal incineration (module C3) while the second part (50%) goes to landfilling and it is stored there (module C4). Module D presents credits resulting from the benefits from avoided thermal energy production (gas).

#### **Data quality**

The data selected for LCA originate from ITB-LCI questionnaires completed by Kronospan HPL Sp. z o. o. using the inventory data, ITB and Ecoinvent v. 3.9 databases and KOBiZE. KOBiZE data is supplemented with Ecoinvent v. 3.9 data on the national electricity mix impact where no specific indicator data is provided. No specific data collected is older than five years and no generic datasets used are older than ten years. The representativeness, completeness, reliability, and consistency are judged as good. Polish electricity was calculated based on Ecoinvent v. 3.9 supplemented by actual national KOBiZE data.

#### **Data collection period**

Primary data provided by Kronospan HPL Sp. z o. o. covers a period of 01.01.2022 – 31.12.2022 (1 year). The life cycle assessments were prepared for Poland and Europe as reference area.

#### **Assumptions and estimates**

Impacts were inventoried and calculated for all products in EDF Kronoplan Kronoart product group. In order to estimate the impact per 1 m<sup>2</sup>, the obtained values are also presented for laminate thicknesses of 6 mm, 8 mm and 10 mm.

#### **Calculation rules**

LCA was performed using ITB-LCA tool developed in accordance with EN 15804 + A2.

#### **Databases**

The data for the processes comes from Ecoinvent v. 3.9 and ITB-Database. Specific data quality analysis was a part of external audit. Polish electricity mix used (production) is 0.761 kg CO<sub>2</sub>/kWh (KOBiZE 2022).

#### LIFE CYCLE ASSESSMENT (LCA) - Results

#### **Declared unit**

The declaration refers to declared unit (DU) – 1 m³ of exterior-grade compact laminates (EDF) Kronoplan Kronoart manufactured by Kronospan HPL Sp. z o. o. (Tables 3-6).

In order to estimate the impact per 1 m<sup>2</sup>, the obtained values are also presented for laminate thicknesses of 6 mm, 8 mm and 10 mm (Tables 7-18).
